## Introduction

The Council is the governing body of the University of Roehampton (“the University”) and carries collective responsibility for overseeing the University’s activities and determining its mission and strategy. The Council ensures compliance with the University’s Articles of Association, Regulations and Procedures.

This Scheme of Delegation (“the Scheme”) sets out the authority held by Council and that which has been delegated by Council to its Committees or to individual Officers of the University to exercise on the Council’s behalf. It aims to provide a single point of reference for the locus of authority within the University for particular types and levels of decision made in the name of, or on behalf of, the University.

The Scheme seeks only to identify responsibility for the final stage of decision-making or formal approval, but not, for example, responsibility for formulating strategic, policy and business proposals, which typically lies with individual officers and committees of the University. The Scheme does however set out the reporting obligations to the relevant accountable body in respect of any decisions made under delegated authority.

In the event of any inconsistency between this Scheme and the University’s Articles of Association, Regulations, Committee Terms of Reference and other regulations, the latter all take precedence over the Scheme.

The Scheme is not intended to be comprehensive, but rather to capture those decisions for which a query is most likely to be raised. If anything is not covered in this Scheme, or if you are not sure where the relevant authority sits for the decision that you are considering, please contact the [University Secretary](#) for advice.

## Framework and principles of delegation

1. As the governing body of the University, the Council is responsible for:
  - Determining the University’s educational character and objectives;
  - Approving its annual estimates of income and expenditure and ensuring its solvency and the safeguarding of its assets;
  - Recommending to the University, in a General Meeting, the approval, revocation, amendment or variation of its Articles of Association;
  - Appointing or terminating the membership of a Council Member;
  - Appointing the Vice-Chancellor, the University Secretary and other Senior Officers;
  - Any act or thing which under the Companies Act 2006 or the Office for Students’ (OfS) regulatory framework is required to be done by the Council.

As stated in Articles 9 and 10, these responsibilities are ‘reserved’ to the Council and, as a general rule, cannot be delegated.

2. For financial decisions, delegated authorisation limits for different types of transaction are set out in a [Schedule of Delegated Authority](#), which forms part of the University's [Financial Regulations](#), and is periodically reviewed by the Finance and Resources Committee.
3. Except as otherwise provided, individuals and committees in whom authority is vested (as set out in this Scheme of Delegation) may delegate to others provided that such delegation is consistent with the Articles of Association, University Regulations, financial and other regulations, policies and procedures. Individuals and bodies who delegate authority should note that it is the responsibility that is being delegated, not the accountability.
4. In exercising delegated authorities, decision-makers should:
  - Consider that the University is a charitable organisation and decisions should always be consistent with the University's charitable objects and seek to ensure good stewardship of the University's assets;
  - Never exceed the level of authority granted to them and must be within the allocated and approved budget (as appropriate);
  - Relate only to their area of operation i.e. not require the commitment of other areas of the University without their prior consent and following consultation as appropriate with relevant parties at a scale proportionate to the impact of the decision.
